SUTLER AGREEMENT AND REGISTRATION FORM

In consideration of receiving acceptance to participate as a “sutler” in the “*Battle for Newbury*” event scheduled for June 8 - 9, 2019 at Spencer-Peirce-Little Farm, in Newbury, MA I/We, the undersigned (please print, below) have acquainted myself/ourselves with, and agree to, the following:

I/We hereby agree to comply with any and all rules and directions of the event organizers, which are communicated to me, particularly as they relate to safety, behavior, participation, authenticity of merchandise and display, etc. I understand that failure to comply will result in my exclusion from the exhibit area assigned to me.

I/We agree not to hold Historic New England or any of its employees or volunteers, The Acton Minutemen/Simon Hunt’s Co., His Majesty’s Tenth Regiment of Foot, event organizers, event volunteers etc. liable or responsible for damages, losses, injury, and/or mental aggravation incurred as a result of participating in or traveling to and/or from the event.

I/We understand event organizers and administrators make no guarantee of a given profit-level for my/our participation at said event.

I/We understand that the site will open at 12:00pm on Friday, May 19, 2017 and I/we will be set-up and ready for the public event opening before Saturday, May 20, 2017 at 9:00am. I/We agree to have all vehicle associated with myself and/or my business in the designated parking area on or before Saturday, May 20, 2017 at 9:00am. I/We agree not to “break camp” until Sunday, May 21, at 1:30pm.

I/We understand that water, firewood and hay will be available on-site but I/we will need something to carry and store it. I/We understand that organizers will not supply food and I/we agree to provide our own food, purchase food on-site or make necessary arrangements with others.

I/We understand anything I/we need for a colonial weekend encampment will be supplied by myself/us. I/we understand that no electricity is available, gasoline powered generators are not allowed and no tables, chairs, flooring, canvas and coverings etc. are supplied by event organizers.

I/We understand that any special accommodations or requests need to be arranged before the event.

I/We will remit a signed *Sutler Agreement and Registration Form*, a signed *Participant Release of Liability Form* (one for each individual) *Current Proof of Insurance*, and the *\$30.00 registration fee*; check payable to Historic New England. My/Our registration will not be considered complete until all of the above items have been received. Confirmation of receipt and participation will be sent via email.
